Follow these guidelines for managing the appropriate and productive use of humor in the workplace.

Always consider the message in your humor -- Are you using humor to say something inappropriate or something you would not otherwise say?



Keep in mind with whom you are "joking around." Would your humor be offensive to a person, or for that

matter, a certain group of people? We aren't always aware of personal struggles of those we work with.

Avoid controversial topics especially political or religious beliefs.

One wrong comment and you can wind up having opposite effect of building a strong TOPIC TO AVOID working relationship with your humor.

Know the difference between using humor productively and goofing off -- Humor should not stand in the

way of getting the job completed; humor should enhance tasks by adding a fun element while not interrupting the work flow.

If you are not sure about vour message or vour audience, just

forget it -- It's about respecting your coworkers and the people around you, so try to stick to a neutral topic if



FORGET IT! you're not sure how received.

In closing, humor can be a great tool and utilized in different work situations, as long as it is used appropriately. The key is to use humor the right way, at the right time and in the right amount in order to improve productivity and working relationships.


A special email account has been established at C&S Business Services dedicated specifically for Payroll questions, submissions and/or vacation requests. The address is:
